REMARKS: This spring is an important source of water to the utilization of
the claimants Arambel Allotment, in Spring Valley. The range and
spring have been used by this ranching operation for over 100 years.
The spring is cleaned out from time to time in order to maintain the
flow. The proof is being filed on a water source, previously covered by
Application No. 8514 dated and filed in the State Engineers Office,
April 23, 1928. This proof is filed to update the owner of record in the
State Engineers Office, and is based on continuous use, as described under
Application No. 8514, by the present owner and his predecessors.

Remarks...The allotments commensurate property has patents dated from as early as 1876. Peter M. Keisch patented part of the Deeded land on 3/20/1876, as did Daniel A. High on 4/22/1879, Franciaco Sagarini on 2/8/1890 and James Savery on 12/22/1888. This ranch has been a livestock operation running both cattle and sheep on this range since it was patented by the early settlers.


