Remarks:

~~In the year 1879 William McCurdy and James Hutton started using this range and water, they ran 1500 head of sheep on this range, watering at these springs during the summer months, they continuously used the range and water from that time until the year 1897 when they sold their stock, range and water rights to John Chapman and Frank McCurdy who continued the use of the range and water, developing more water and running about 2000 head of sheep thereon during the summer months, Chapman and McCurdy later sold their stock, range and water rights to F. A. Raabe who continued the use as above stated and in July, 1927, Raabe sold his range, Chin Creek Ranch irrigation and all stockwatering rights to the peponent, William Sellas, who ran 2500 head of sheep on this range during the summer of 1927.~~


