(21) The character of the soil is Sandy Loam (Sandy, gravelly, loam) The soil needs 5 acre-feet per annum to properly irrigate the crops. A continuous flow of 0.25 cubic feet of water per second, during the irrigation season of 12 months, is needed to irrigate each 100 acres of land.

(22) Remarks: The water is diverted from its source within the NE 1/4 NW 1/4 Section 1, T 22 S, R 61 E, MD.M. or at a point from which the West 1/4 corner of said Section 1 bears South 46°35'59" West a distance of 2142 feet.
