(20) Water from the source given and through the works described is also used for the following purposes other than irrigation: Domestic

(21) The character of the soil is Sandy Loam The soil needs 5 acre-feet
(Sandy, gravelly, loam)
per annum to properly irrigate the crops. A continuous flow of 0.25 cubic feet of water per second, during the irrigation season of 12 months, is needed to irrigate each 100 acres of land.

(22) Remarks:
The water is converted from its source within the NW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 1,
T 22 S, R 61 E, MD.M. or at a point from which the West $\frac{1}{4}$ corner of said
Section 1 bears North 21°39'15" West a distance of 358 feet.
