duly sworn, deposes and says that the facts relative to the appropriation of water by
Roger Smith are full and correct to the best of his
knowledge and belief.

(15) The maximum acreage irrigated in any year was 506.00 acres.

(16) The water claimed has (~~has not~~) been used for irrigation each and every year since the right was initiated.

(18) The claimant's water right was (was not) recorded in the office of the County Recorder of Eiko County, said record being at page 213 of Book 3 of Water rights, and being a claim for ALL of water for the irrigation of
 acres of land in the following legal subdivisions: "Gedney Ranch"

(19) The map provided by the State Engineer and attached hereto as a part of this proof is hereby accepted as correctly showing the ditch lines or irrigation works diverting or conveying the water claimed and the lands irrigated.

(20) Water from the source given and through the works described is also used for the following purposes other than irrigation: stockwatering and domestic.

(21) The character of the soil is gravelly The soil needs 5.0 acre-feet
(Sandy, gravelly, loam)
per annum to properly irrigate the crops. A continuous flow of 3.0 cubic feet of water per second, during the irrigation season of 9 months, is needed to irrigate each 100 acres of land.

(22) Remarks: This creek was in the past was sometimes called Gedney Creek.
