While performing field inspections of the Basin Inventory, NRS 533.364 for submittal to the Division of Water Resources State Engineers office, the actual location of Vested stock watering was found to be in the incorrect Point of Diversion. This is submitted as an amendment to the original Proof, V02556, submitted in 1966.
