NOTE--Failure to record in the county in no way invalidates a water right, but if ditch or right was so recorded, supply full information under (19)

(19) Water from the source given and through the works described is also used for the following purposes other than irrigation: Stockwatering purposes along the Henderson Creek Channel from its head waters to a point in the NW $\frac{1}{4}$  Section 34, T. 25 N., R. 51 E., M. D. B. & M.

(20) The character of the soil is loam (Sandy, gravelly, loam) The soil needs 4 acre-feet per annum to properly irrigate the crops. A continuous flow of 2.0 cubic feet of water per second, during the irrigation season of 6 months, is needed to irrigate each 100 acres of land.

(21) Remarks: The information regarding acreages irrigated in paragraph 14 are assumed to be much the same as present day cultures. An early date of 1893, which is the date of survey of the Township Plat which shows fences and activity in these areas, is more than likely the earliest date for first culture.

Although Eureka County records show later culture dates than 1893, the date of the original occupation of the land must have been much earlier.

The undersigned, being first duly sworn, deposes and says that the facts relative to the appropriation of water by Eureka Livestock Co. are full and correct to the best of his knowledge and belief.
