Remarks.....
This spring is an important source of water to the utilization of the claimants Pinto Creek Allotment and deeded property. The range and spring have been used by this ranching operation for over 100 years. The spring is cleaned out from time to time in order to maintain the flow. This proof is being filed on a water source^c, previously covered by Proof No. 01082 dated and filed in the State Engineers' office, April 6, 1912. This proof is being filed to up date the owner of record in the State Engineers' Office and is based on continues use, as described under Proof No. 01082, by the present owner and his predecessors.

Remarks. The allotments commensurate property has patent dated from as early as 1876. Peter M. Keisch patented part of the Deeded land on 3/20/1876, as did Daniel A. High on 4/22/1879, Francisco Sagarini on 2/8/1890 and James Savery on 12/22/1888. This ranch has been a livestock operation running both cattle and sheep on this range since it was patented by the early settlers.

The undersigned, being first duly sworn, deposes and says that the facts relative to the appropriation of water by UNITED DRESSED BEEF, INC. are full and correct to the best of his knowledge and belief.
