- Year 1872 to 1911, 2800 cattle
- If water was not used, or used in reduced quantity at any time, full information as to causes and duration of non-use should be given.
- Year 1912 to 1919, 2700 cattle
- Year 1920 to 1942, 3900 cattle
- Year 1943 to 1949, 2400 cattle
- Year 1950 to 1982, 1400 cattle

(11) The amount of water which has been necessary to be diverted for this purpose has been

0.07 (30 GPM) cubic feet per second.

(12) The works are located at NW $\frac{1}{4}$  SE $\frac{1}{4}$  of Section 14, T. 44N., R. 55E., M.D.B.


