(3) The water is diverted by small pipeline to watering troughs

(4) The water is diverted at the following point(s) SW $\frac{1}{4}$  NW $\frac{1}{4}$  Section 11, T. 44N., R. 55E., M.D.B. & M. or at a point from which the NE corner of said

If water was not used, or used in reduced quantity at any time, full information as to causes and duration of non-use should be given.  
Year 1912 to 1919, 2700 cattle  
Year 1920 to 1942, 3900 cattle  
Year 1943 to 1949, 2400 cattle  
Year 1950 to 1982, 1400 cattle

(11) The amount of water which has been necessary to be diverted for this purpose has been

0.07 (30 GPM) cubic feet per second.  
448.83 gal. per min. equals 1 cubic foot per second.

(12) The works are located at SW $\frac{1}{4}$  NW $\frac{1}{4}$  Section 11, T.44N., R. 55E., M.D.B. & M.  
Describe as being within a 40-acre subdivision, section, township and range of public survey. If on unsurveyed  
land, it should be stated.

Remarks Originally the spring area was used to water cattle. In  
later years a pipeline and watering trough were installed.


