Year 1912 to 1919, 2700 cattle  
Year 1920 to 1942, 3900 cattle  
Year 1943 to 1949, 2400 cattle  
Year 1950 to 1982, 1400 cattle

(11) The amount of water which has been necessary to be diverted for this purpose has been  
0.07 (30 GPM) cubic feet per second.  
448.83 gal. per min. equals 1 cubic foot per second.

(12) The works are located at NW $\frac{1}{4}$ , NW $\frac{1}{4}$ , Section 12, T. 45N., R. 55 E., M.D.B. &  
Describe as being within a 40-acre subdivision, section, township and range of public survey. If on unsurveyed


