(2) Source of water Unnamed Spring No. 6

(3) The water is diverted by spring area, natural channel, and pipeline to
trough.

(4) The water is diverted at the following point(s) NW 1/4 NE 1/4 Section 30, T.21N., R.23E.,
M.D.B. & M., or at a point from which the E 1/4 corner of said Section
30 bears South 45°17' East, 3053 feet.

(5) The water is impounded in trough and natural channel

(6) The construction of the ditch or other works was begun prior to 1905
and completed

(7) The nature of the claimant's title to the land upon which the source of water and place of use
are located is patented land and public domain subject to grazing permit

(8) The claimant's water right was (was not) recorded in the office of the County Recorder of
Unknown County, at Page of Book of

NOTE—Failure to record in the county in no way invalidates a water right, but if water right was so recorded, supply full information under (8).

(9) The approximate number of animals watered by the claimant during the first year <sup>Date</sup> prior, to 1 was at least ~~was~~ 90 cattle 40 horses - sheep or - Other. The watering was conducted during each of the following months. Year round depending on the severity of the winter and the feed available.

(10) The approximate number of animals watered by the claimant in subsequent years was as follows:

The number varies depending on federal grazing allotment amounts. If water was not used, or used in reduced quantity at any time, full information as to causes and duration of non-use should be given. since the Taylor Grazing Act. In 1936, 90 cattle and 40 horses were allowed. Prior to the Taylor Grazing Act uses were frequently by larger numbers. See supplemental information to be filed under this proof.

(11) The amount of water which has been necessary to be diverted for this purpose has been .0041 cubic feet per second. 448.83 gal. per min. equals 1 cubic foot per second.

(12) The works are located at NW<sup>1</sup>/<sub>4</sub>NE<sup>1</sup>/<sub>4</sub> Section 30, T.21N., R.23E., M.D.B. & M. Describe as being within a 40-acre subdivision, section, township and range of public survey. If on unsurveyed land, it should be stated.
