(19) The character of the soil is Sandy Silt..... A continuous <sup>maximum</sup> flow of 0.4.....cubic feet of water per second has been used to irrigate 68.5.....acres of land and 274.....acre-feet per acre per annum have been used to irrigate the crops.

(20) Remarks: Home Camp Land and Livestock Company has made beneficial use of the water from CCC Spring for irrigation and stockwater since their acquisition of the property in 1937, to the present. Prior owners also used the water for the same purpose from its patent in the 1870's until the Home Camp purchase. Water from CCC Spring is commingled with water from Horse Canyon Spring, Mare Spring and Mare Pasture Spring to irrigate the entire land. In the spring, more water is available due to natural runoff. The first evidence of water use was in the late 1870's when the land was surveyed. Further documentation is contained in an affidavit by David L. Grove who was born in 1894 and is familiar with Home Camp and further substantiates the beneficial use of water prior to the 1900's. The signed notarized copy of Mr. Grove's affidavit is attached. The affidavit shows the continuous use of water to the present.

The undersigned, being first duly sworn, deposes and says that the facts relative to the appropriation of water by Home Camp Land and Livestock Company, Inc. are full and correct to the best of his knowledge and belief. Richard W. Arden, Water Right Surveyor, Agent for Claimant.
