Remarks This well was drilled sometime prior to 1910 and has been equipped with a pump and motor off and on over the years. The well has produced an artesian flow as high as 450 gallons per minute but due to other development in the valley the artesian head has diminished to the present 50 gallons per minute. To the best of our knowledge the well was re-drilled in 1928 and the diameter of the casing was reduced.
