(20) Remarks: This well was drilled sometime around 1928 when the Dangberg Ranch contracted to have six irrigation wells drilled. The well was redrilled and deepened sometime around 1945. Pumping from this well has supplemented Carson River rights held by the Dangberg Ranch for the last 60 years. Some lands irrigated from this well do not have Carson River decreed rights.


