STOCK WATERING PURPOSES

- (1) Name of Claimant GLASER LAND AND LIVESTOCK COMPANY, a Nevada corporation [Street and No. or P. O. Box No.] of [City or town] Halleck [State and Zip Code No.] Nevada 89824
- (2) Source of water [Name of natural water source] Buttes Channel and tributaries
- (3) The water is diverted by [Dam, ditch, pipe line, natural channel, spring area, etc.] natural.
- (4) The water is diverted at the following point(s) [Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land it should be stated. Diversion over a channel reach must be described by course and distance to a section corner for both the beginning and end of such reach.] The beginning of the reach being at a point located in the NE1/4 NE1/4 of Section 25, T37N, R55E, MDB&M from which the Northeast corner of said Section 25 bears N30°44'00"E a distance of 1,430.00 feet and the end of the reach being in the channel at a point located in the NW1/4 SE1/4 of Section 32, T37N, R56E, MDB&M from which point the Southeast corner of said Section 32 bears S43°53'00"E a distance of 3,150.00 feet.
- (5) The water is impounded in [Troughs, tanks, pools, reservoir, natural channel, etc.] natural pools and channels.
- (6) The construction of the ditch or other works was begun [Date] none and completed [Date] none.
- (7) The nature of the claimant's title to the land upon which the source of water and place of use are located is [Patented, deeded, public domain with grazing permit, etc.] public land used in connection with grazing permit and deeded land of others used in conjunction with a

grazing permit upon adjoining public domain and the Open Range Law of the State of Nevada.

- (9) The approximate number of animals watered by the claimant during the first year [Date] 1873 was unknown cattle unknown horses unknown sheep or [Other] unknown. The watering was conducted during each of the following months. The number of animals is unknown in 1873, but would have minimal (5 to 10 head of cattle) in that year and increasing to 183 head of cattle and 7 horses belonging to Claimant's predecessors and using this source by 1904. The source used during the months of March through November.
- (10) The approximate number of animals watered by the claimant in subsequent years was as follows: [If water was not used, or used in reduced quantity at any time, full information as to causes and duration of non-use should be given] 183 head of cattle and 7 head of horses of Claimant's predecessors used this source during each subsequent year except during periods of drought or herd depletion for economic reasons.
- (11) The amount of water which has been necessary to be diverted for this purpose has been [448.83 gal. per min. equals 1 cubic foot per second] .014 cubic feet per second.
- (12) The works are located at [Describe as being within a 40-acre subdivision, section, township and range of public survey. If on unsurveyed land, it should be stated] None. Natural pools and channel along reach within E1/4 NE1/4; S1/2 SE1/4 of Section 25, T37N, R55E; S1/2 NW1/4; S1/2 S1/2; NE1/4 SW1/4; NW1/4 SE1/4 of Section 30; NE1/4 NE1/4 of Section 31; S1/2 NW1/4; NE1/4 SW1/4; NW1/4 SE1/4 of Section 32, T37N, R56E, MDB&M.

Remarks: The quantity of water necessary is computed on the flow necessary to water the number of cattle using the source in a six-hour period of flow.

The priority as to year is based upon affidavits of CARRIE G. SMIRALDO, GEORGE M. SMIRALDO, NORMAN D. GLASER AND ARTHUR C. GLASER submitted in connection with this

application, public records and family history, and the numbers of livestock upon information and experience of NORMAN D. GLASER and ARTHUR C. GLASER and factual data through public records and family history.

Application No. 38110 is included as a portion of this Proof which application is for supplemental water to that of this Proof.

The undersigned, being first duly sworn, deposes and says that the facts relative to the appropriation of water by GLASER LAND AND LIVESTOCK COMPANY, a Nevada corporation are full and correct to the best of his knowledge and belief [If proof is not made by claimant, deponent should state on this line by virtue of what authority he represents the claimant.] Deponent is executing this Proof pursuant to his authority as President.


