(20) Remarks: 100 - 400 GPM FROM THIS SOURCE WITH ADDITIONAL WATER FROM ADJACENT WELL AND HORIZONTAL WELL PROVIDED WATER FOR IRRIGATING VARIOUS CROPS ON 160 ACRES. WATER UNDER THIS CLAIM WAS COMINGLED WITH AND SUPPLEMENTED WITH WATER FROM THESE OTHER TWO SOURCES (UNDERGROUND WELL AND HORIZONTAL WELL) TO MEET THE NEEDS FOR IRRIGATING THE 160 ACRES PLUS DOMESTIC AND STOCKWATER NEEDS.
