The point of diversion starts again in the SW¹/₄NW¹/₄ Section 23, T. 39 N., R. 52 E., MDM at a point from which the NW corner of said Section 23 bears N. 30°18' W., 2,683 feet which follows the natural channel to a point in the SW¹/₄NW¹/₄ Section 23, T. 39 N., R. 52 E., MDM at a point from which the NW corner of said Section 23 bears N. 09°55' W., 1,635 feet. The point of diversion again starts in the NE¹/₄NE¹/₄ Section 22, T. 39 N., R. 52 E., MDM at a point from which the NE corner of said Section 22 bears N. 01°34' W., 1,537 feet which follows the natural channel to a point in the NW¹/₄NE¹/₄ Section 22, T. 39 N., R. 52 E., MDM at a point from which the NE corner of said Section 22 bears N. 85°40' E., 1,570 feet.

Remarks: Newspaper articles provide some evidence of early use. The Elko Independent of April 29, 1875, Page 3, reports that GEORGE BRADLEY drove 500 head of cattle to an area west of Tuscarora. The Tuscarora Daily Mining Review of November 27, 1877 reports a shipment of 392 head of cattle from the area by BRADLEY, RUSSELL and SCOTT. BRADLEY and RUSSELL are predecessors to the present owners. Therefore, there is an indicated priority of 1877 for a portion. Other predecessors were GEORGE W. GRAYSON and WARREN W. WILLIAMS with priority of use of 1896 and earlier, based on ownership of livestock as evidenced by records of the Elko County Assessor.

As to numbers of livestock, this is particularly difficult as the majority of the operation is in the Humboldt River Basin and Lander County. The area of the Owyhee River Basin is high elevation and is normally used in the summer season for grazing, with numbers increasing as the season progresses. One indication of numbers is from those recorded in assessment records of the Treasurer of Elko County, Nevada. For the year 1894, RUSSELL & BRADLEY LAND AND CATTLE CO. was assessed for 2,000 cattle and 200 horses. As the operation was in Lander County and Elko County, this number would be a proportion of the entire herd estimated to be in Elko for the entire year. This was used for tax purposes and to account for the fact that during winter months, a very small proportion of the livestock were in Elko County, and during the late summer, almost all of the herd was in the County. The high numbers would normally occur after July 15, but depending upon weather conditions, they could be as early as April 15.

Additional evidence of livestock use is found. The records of the Elko County Treasurer show GEORGE W. GRAYSON being assessed for 800 cattle and 200 horses in 1896. WARREN W. WILLIAMS acquired range in and near the area in 1889 from J.D. SMELSER (see Nevada's Northeast Frontier, Page 415, authored by PATTERSON, ULPH and GOODWIN). As one of the GRAYSON base ranches was near the Owyhee River Drainage, being the Stampede Ranch, located in Township 39 North, Range 52 East, it is assumed that the entire grazing season was upon the open range and a majority within the drainage. Additional livestock use through the area was made by W.T. JENKINS and WARREN W. WILLIAMS by sheep, as reported in the publication entitled Nevada's Northeast Frontier. This would have been high numbers in the Spring and Fall. WILLIAMS was reported to have in excess of 40,000 sheep (see Nevada's Northeast Frontier, Page 417), and W.T. JENKINS in excess of 18,000 sheep as evidenced by chattel mortgages of record. All of said sheep use has been changed to cattle since 1905.

These major users of the area, GEORGE W. GRAYSON, RUSSELL & BRADLEY LAND AND CATTLE COMPANY, W.T. JENKINS, and WARREN W. WILLIAMS are the basis of vested stock water rights.

From the above evidence, a priority of use is claimed as of not later than 1896, with a season of use of April 15 to October 15.

The area of use of RUSSELL LAND AND CATTLE COMPANY (successor to RUSSELL & BRADLEY LAND AND CATTLE COMPANY) is further documented by the range claim map filed in the State Water Engineer's office subsequent to the passage of the "Three Mile Limit" statute in 1925 (Map 89-30).

The undersigned, being first duly sworn, deposes and says that the facts relative to the appropriation of water by Western States Minerals Corporation

are full and correct to the best of his knowledge and belief.

If proof is not made by claimant, deponent should state on this line by virtue of what authority he represents the claimant.


