(20) Remarks

Water flows down Butcher Canyon ditch enters the pipeline at Jersey Hot Spring "F". The commingled water flows approximately three miles and empties into Home Station Ranch reservoir, from whence fields described in Item 13 (above). This pipeline or its ancestral predecessor has been in use since at least 1886, as evidenced by deeds in the Abstract of Title found in V01933. Traces of the pipe line are delineated on GLO maps before 1915.




