Records show that livestock numbers varied from year to year. Cattle use from about 1880 to the present has been mainly in the winter. 2000 sheep were run in 1910 and this use changed to 1000-2000 angora goats beginning in 1923 and continuing until 1942. Sheep and cattle were run until 1976. Since then cattle have used the area.

(11) The amount of water which has been necessary to be diverted for this purpose has been 0.01 cubic feet per second.
448.83 gal. per min. equals 1 cubic foot per second.


