Pursuant to N.R.S. 533

(1) Name of Claimant JULIAN TOMERA RANCHES, INC., STONEHOUSE DIVISION [Street and No. or P. O. Box No.] HC 65, BOX 11 of [City or town] Carlin [State and Zip Code No.] Nevada 89822.

(2) Source of water [Name of natural water source] Beards Creek Spring.

(3) The water is diverted by [Dam, ditch, pipe line, natural channel, spring area, etc.] spring area and pipeline to trough.

(4) The water is diverted at the following point(s) [Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land it should be stated. Diversion over a channel reach must be described by course and distance to a section corner for both the beginning and end of such reach.] At a point within the NE1/4 NW1/4 of Section 20, Township 32 North, Range 53 East, MDB&M from which the Northwest corner of said Section 20 bears North 86°08'12" West a distance of 1,758.11 feet.

(5) The water is impounded in [Troughs, tanks, pools, reservoir, natural channel, etc.] pools and trough.

(6) The construction of the ditch or other works was begun [Date] Unknown and completed [Date] Unknown.

(7) The nature of the claimant's title to the land upon which the source of water and place of use are located is [Patented, deeded, public domain with grazing permit, etc.] NE1/4 NW1/4 of Section 20, Township 32 North, Range 53 East, MDB&M being public domain upon which Claimant holds a grazing permit.

(9) The items of evidence for the numbers of livestock and date of priority are APPLICATION FOR GRAZING PERMIT dated March 20, 1935 executed by Balsamina Tomera.

(10) The approximate number of animals watered by the claimant during the first year [Date] 1903 was 20 cattle      horses      sheep or [Other]     . The watering was conducted during each of the following months April 1 to October 1.

(11) The approximate number of animals watered by the claimant in subsequent years was as follows: [If water was not used, or used in reduced quantity at any time, full information as to causes and duration of non-use should be given] The numbers of livestock increased annually until the approximate number using this source reached a maximum of 200 head.

(12) The amount of water which has been necessary to be diverted for this purpose has been [448.83 gal. per min. equals 1 cubic foot per second] .006 cubic feet per second.

The priority information is based upon the APPLICATION FOR GRAZING PERMIT submitted by Balsamina Tomera dated March 20, 1935 filed with the United States Department of the Interior, wherein a total of 970 head of livestock grazed the open range within which this source is located for the season of April 1 to October 1.

This source is located within an area of private land upon which the use is correlated with other lands administered by the Bureau of Land Management. Therefore, the season of use and numbers of livestock may vary due to management as required. The grazing area adjacent to this source is only a portion of the entire range area used by Claimant. The number of livestock using this source represents the average use as dictated by forage and management practices.

The application for grazing states that the grazing use in the area ended on October 1. Past practices and use has been to October 15.

The original application for grazing of Balsamina Tomera states that the area in which this source is located had been

used for grazing for 32 years prior to 1935. Therefore, a priority of 1903 is claimed.

The Elko County tax roll for year of 1903 indicates that less than 970 livestock were operated. Therefore, the approximate number which used the source in the first years is estimated to be 20 head, increasing to 200 head by 1935.

The undersigned, being first duly sworn, deposes and says that he owns or controls the livestock presently watered by the Claimant, and that the facts relative to the proof of subsisting right by JULIAN TOMERA RANCHES, INC., STONEHOUSE DIVISION, a Nevada corporation are full and correct to the best of his knowledge and belief [If proof is not made by claimant, deponent should state on this line by virtue of what authority he represents the claimant.] \_\_\_\_\_.




