- Item 9. The approximate number of animals watered by the claimant prior to 1877 was at least 100 cattle. The watering was conducted during the months of March through November.
- Item 10. The approximate number of animals watered by the claimant in subsequent years was as follows: Varying numbers depending upon the time of year but not exceeding 775 head of cattle.
- Item 11. The amount of water which has been necessary to be diverted for this purpose has been .02421 cubic feet per second.

Remarks

The numbers of livestock set forth in Items 9 and 10 is based upon the early livestock operation of Daniel Murphy in the area.

The Decree of Distribution in the Estate of Daniel Murphy which is recorded in Book 12 of Miscellaneous Records at Page 342, Elko County, Nevada, distributes to Daniel M. Murphy and Diana M. Hill, among other lands, portions of Sections 7 and 8, T 43N, R 55E, MDB&M. The claimant is the present owner of those lands distributed in said sections and other lands. In addition approximately 2,000 head of JP cattle were distributed along with 2,600 head of Diamond A cattle and a half interest of 1,000 Murphy and Cleaveland cattle. It is assumed the Murphy and Cleaveland cattle were resident in present White Pine County which is where a portion of the land was described. The date of death of Daniel Murphy stated in the Decree of Distribution is June 1, 1884.

Daniel Murphy owned other lands throughout the North Fork, Diamond A Desert and Gold Creek area. This is substantiated by the Water Claim of Murphy and Hill recorded in Book 1 of Water Rights at Page 677, Elko County, Nevada which claims diversions of Foreman Creek, Barkley Creek and Johnson's Creek (North Fork area), Penrod Creek (Gold Creek area) and Mary's River ranging from 1872 to 1884. This also evidences open range cattle grazing in the area of this proof.

Bernard Murphy conveyed to Daniel Murphy, et ux, all cattle owned in Nevada by conveyance dated February 19, 1877, and recorded in Book 2 of Misc. Records at Page 719, Elko County, Nevada.

Based upon the above, a conservative priority claim of 1877 is made.
