Pursuant to N.R.S. 533
As Amended by Chapter 473, 1993 Statutes, Sections 2, 3 and 4
Effective October 1, 1993

(1) Name of Claimant JOSEPH W. HEGUY [Street and No. or P. O. Box No.] 146 West Juniper Street of [City or town] Elko [State and Zip Code No.] Nevada 89801.

(2) Source of water [Name of natural water source] East Fork of Beaver Creek and its tributary streams (which include Summit Creek and Cabin Creek) and springs within its drainage basin.

(3) The water is diverted by [Dam, ditch, pipe line, natural channel, spring area, etc.] natural channel and spring areas.

(4) The water is diverted at the following point(s) [Describe as being within a 40-acre subdivision of public survey, and by course and distance to a section corner. If on unsurveyed land it should be stated. Diversion over a channel reach must be described by course and distance to a section corner for both the beginning and end of such reach.]

This source consists of five (5) segments of the East Fork of Beaver Creek and its tributaries of Summit Creek and Cabin Creek. The segments are all contributory to the flow of East Fork of Beaver Creek and the segments are the result of several fenced fields or grazing allotments in which Applicant makes no use.

Segment 1 has diversion throughout the reach of the source, beginning at the head of each of twelve (12) tributaries and ending at a point where the source leaves the area of grazing use of the Claimant.

The beginning of each tributary is described as follows:

- A. A point within the NE1/4NE1/4 of Section 18, Township 42 North, Range 57 East, MDB&M from which the Northeast corner of said Section 18 bears North 35°20'57" East a distance of 49.12 feet.
- B. A point within Lot 3 of Section 18, Township 42 North, Range 57 East, MDB&M from which the East one-quarter corner of Section 13, Township 42 North, Range 56 East, MDB&M bears North 75°21'03" West a distance of 602.31 feet.

- C. ✓ A point within the SW1/4NE1/4 of Section 13, Township 42 North, Range 56 East, MDB&M from which the East one-quarter corner of said Section 13 bears South 78°44'19" East a distance of 1,425.70 feet.
- D. ✓ A point within the SE1/4NW1/4 of Section 19, Township 42 North, Range 57 East, MDB&M from which the Northwest corner of said Section 19 bears North 42°09'15" West a distance of 2,184.37 feet.
- E. ✓ A point within the NE1/4SW1/4 of Section 30, Township 42 North, Range 57 East, MDB&M from which the Northwest corner of Section 19, Township 42 North, Range 57 East, MDB&M bears North 16°34'06" West a distance of 8,733.60 feet.
- F. ✓ A point within the NE1/4NE1/4 of Section 3, Township 41 North, Range 57 East, MDB&M from which the East one-quarter corner of Section 33, Township 42 North, Range 57 East, MDB&M bears North 61°13'19" West a distance of 5,893.18 feet.
- G. ✓ A point within the NE1/4NE1/4 of Section 3, Township 41 North, Range 57 East, MDB&M from which the East one-quarter corner of Section 33, Township 42 North, Range 57 East, MDB&M bears North 56°26'16" West a distance of 5,769.17 feet.
- H. ✓ A point within the NW1/4NW1/4 of Section 10, Township 41 North, Range 57 East, MDB&M from which the Southeast corner of said Section 10 bears South 48°36'23" East a distance of 6,908.91 feet.
- I. ✓ A point within the NE1/4NW1/4 of Section 14, Township 41 North, Range 57 East, MDB&M from which the Northwest corner of said Section 14 bears North 83°27'26" West a distance of 2,571.46 feet.
- J. ✓ A point within the NE1/4SE1/4 of Section 14, Township 41 North, Range 57 East, MDB&M from which the Southeast corner of said Section 14 bears South 26°12'02" East a distance of 1,819.44 feet.
- K. ✓ A point within the NW1/4SE1/4 of Section 19, Township 41 North, Range 58 East, MDB&M from which the Northwest corner of Section 24, Township 41 North, Range 57 East, MDB&M bears North 71°41'23" West a distance of 8,571.80 feet.
- L. ✓ A point within the NW1/4SE1/4 of Section 30, Township 41 North, Range 58 East, MDB&M from which the West one-quarter corner of Section 25, Township 41 North, Range 57 East, MDB&M bears North 88°46'00" West a distance of 8,796.66 feet.

The end of the reach of Segment 1 is at a point within the NW1/4NE1/4 of Section 22, Township 41 North, Range 57 East, MDB&M, from which the North one-quarter corner of Section 22 bears North 34°45'41" West a distance of 1,603.02 feet.

Segment 2 has diversion throughout the reach of the source beginning at the head of each of five (5) tributaries and ending at a point where the source leaves the area of grazing use of the Claimant.

The beginning of each tributary is described as follows:

- A. A point within the NW1/4SW1/4 of Section 32, Township 41 North, Range 58 East, MDB&M from which the Southwest corner of said Section 32 bears South 09°12'34" West a distance of 2,718.56 feet.
- B. A point within Lot 2 of Section 32, Township 41 North, Range 58 East, MDB&M from which the Southwest corner of said Section 32 bears South 68°09'04" West a distance of 1,731.49 feet.
- C. A point within the SW1/4NW1/4 of Section 8, Township 40 North, Range 58 East, MDB&M from which the South one-quarter corner of said Section 8 bears South 23°05'05" East a distance of 4,035.51 feet.
- D. A point within the SW1/4NE1/4 of Section 7, Township 40 North, Range 58 East, MDB&M from which the South one-quarter corner of said Section 7 bears South 12°37'05" West a distance of 3,743.86 feet.
- E. A point within the SE1/4NW1/4 of Section 1, Township 40 North, Range 57 East, MDB&M from which the Northwest corner of said Section 1 bears North 43°24'48" West a distance of 2,805.39 feet.

The end of each of the reaches is at a point within the NW1/4SW1/4 of Section 35, Township 41 North, Range 57 East, MDB&M, from which the Northwest corner of Section 1, Township 40 North, Range 57 East, MDB&M bears South 37°42'23" East a distance of 2,814.92 feet.

Segment 3 has the following described reach:

Beginning at a point within the SW1/4NE1/4 of Section 2, Township 40 North, Range 57 East, MDB&M from which the West one-quarter corner of said Section bears South 89°39'04" West a distance of 2,872.13 feet; thence following down the natural channel to a point within Lot 4 of Section 2, Township 40 North, Range 57 East, MDB&M from which the Northwest corner of said section bears North 66°12'50" West a distance of 684.58 feet.

Segment 4 has the following described reach:

Beginning at a point within Lot 2 of Section 3, Township 40 North, Range 57 East, MDB&M from which the Northeast corner of said section bears North 83°36'35" East a distance of 2,028.61 feet; thence following down the natural channel to a point within the NW1/4SE1/4 of Section 4, Township 40 North, Range 57 East, MDB&M from which the Southeast corner of said section bears South 45°31'55" East a distance of 2,187.71 feet.

Segment 5 has the following described reach:

(8) The claimant's water right was not recorded in the office of the County Recorder of _____ County, at Page _____ of Book _____ of _____.

(9) The items of evidence for the numbers of livestock and date of priority are copies of Affidavit of Jean B. Ardans, chain of title included in "Remarks" and Affidavit of Walter I. Leberski with documents attached.

(10) The approximate number of animals watered by the claimant during the first year (Date) 1900 was _____ cattle _____ horses 5,000 sheep or (Other) _____. The watering was conducted during each of the following months April 1 to November 1.

(11) The approximate number of animals watered by the claimant in subsequent years was as follows: [If water was not used, or used in reduced quantity at any time, full information as to causes and duration of non-use should be given] This source was used as a part of a combined sheep and cattle operation. Subsequent to 1935 the class of use was changed and the source was used with sheep only, with the customary use being 1,100 sheep June 15 to July 1 and 2,000 sheep September 15 to September 30.

(12) The amount of water which has been necessary to be diverted for this purpose has been [448.83 gal. per min. equals 1 cubic foot per second] 0.0125 cubic feet per second.

(13) The works are located at [Describe as being within a 40-acre subdivision, section, township and range of public survey. If on unsurveyed land, it should be stated. None.

Remarks [Improvements, title, etc.]

This proof is for a portion of use made by a 4,500-head sheep operation during the period of April 15 to November 1, and 175 head of cattle for the period of May 15 to October 1. The sheep operation has historically made use of a number of water sources with varying numbers and during different periods, as dictated by forage growth due to elevation, availability of water due to seasonal flow, and management of the livestock. Basically, this operation historically had the total sheep numbers on the lower reaches of the North Fork of the Humboldt River and tributaries to

the North Fork, in Township 37 North through Township 40 North, Ranges 57 and 58 East, MDM (Stag Mountain and Lower North Fork) for the period of approximately April 1 to July 1. After July 1, a portion of the numbers went to a range area upon the Forest Service in Townships 44 and 45 North, Ranges 58 and 59 East, MDM (Marys River Basin), a portion to areas in Townships 41 and 42 North, Range 56 through Range 58 East, MDM (Beaver Creek area) and the balance remaining in the Stag Mountain and Lower North Fork until late September, at which time all sheep were removed from Marys River Basin and Beaver Creek area to the Stag Mountain area-Lower North Fork area until November 1, at which time they moved to a winter grazing area. The numbers of livestock and season of use in this proof represent the historical use on this source based upon the operation as described. Cattle use has been confined to a specific area. The priority information as to season and numbers concerns the entire operation, based upon evidence cited, and the season and numbers of this proof are based upon past customary use from experience of the Claimant.

The Claimant is a successor of two (2) operations which established early use of the source for stockwater, the Turreuil Ranch and the Itcaina Ranch. Evidence of the early use of each is as follows:

Tourreuil Ranch

The original application of Andrew Tourreuil, a predecessor of Joseph W. Heguy, with the Grazing Service, a predecessor to the Bureau of Land Management, dated April 15, 1935, states that 5,500 sheep were customarily grazed in Townships 41 North, Township 42 North, and Township 43 North, Range 56 East and Range 57 East for the period of April 1 to November 1, with winter use in the Currie District. See copy attached to the Affidavit of Walter I. Leberski. That this was the original licensed use is evidenced by the 1935 Temporary Grazing License attached to said Affidavit. The 1944 application of Alex Heguy states acquisition of the Tourreuil property, applies for 2,500 sheep, and evidences approval of the numbers and season. Various records evidence a reduction in use from 5,500 sheep in 1935 to 2,500 in 1944. The number of 2,500 sheep, plus 175 cattle, is claimed under the early use by Tourreuil. The priority claimed is 1900, based on the statement of Andrew Tourreuil in the April 15, 1935 application, Item 8, which states that those lands involved in the area of use have been used for grazing for at least 35 years, establishing a priority of 1900.

In addition, Humboldt National Forest records corroborate the claim of Andrew Tourreuil of use upon the Humboldt National Forest as shown in his application to the Grazing Service. Paid Permit Record Cards maintained in that office show that in 1929, Andrew Tourreuil acquired a 2,500 sheep permit from the Williams Estate Company in Forest lands, and subsequently was licensed in 1929 upon the National Forest for 7,000 sheep for the period of July 1 to October 15. The area of use is assumed to be Marys River Basin, a portion of the Claimant's present area of use.

In summary, the claim of numbers from the Andrew Tourreuil operation is 2,500 sheep, and 175 cattle (conversion of a portion of Tourreuil operation from sheep to cattle), for the period of April 1 to November 1 with at least a portion being upon the National Forest for the period of July 1 to October 1, with numbers and season of use adjusted from early use to reflect current conditions, with a priority of 1900.

Itcaina Purchase

The Itcaina purchase consists of a portion of two (2) priorities, that being established by Pete Itcaina and that established by J.R. Bradley & Sons.

Pete Itcaina initiated a sheep grazing operation using sources on the East Fork of Beaver Creek, drainages from the West Side of Stag Mountain, and Hanks Creek Basin, starting in about 1907, and increasing to as high as 19,000 sheep by 1930. See Affidavit of Jean B. Ardans and Affidavit of Walter I. Leberski attached. The season of use of April 1 to November 1 is evidenced in information contained in Affidavit of Walter I. Leberski. The Claimant is a successor to a portion of this use.

The J. R. Bradley & Sons portion of the claim originated in 1885 under the firm name of Mason-Bradley. Through changes of ownership, the operation became J.R. Bradley & Sons and ranged 12,000 head of cattle in the Marys River country and Bruneau Basin of northern Elko County. The above is as stated in the publication entitled Nevada's Northeast Frontier by Edna B. Patterson, Louis A. Ulph and Victor O. Goodwin.

The Claimant is a successor in interest to a portion of the Pete Itcaina operation and the J.R. Bradley & Sons through a purchase. The chain of title of lands pertinent to this portion of the claim is as follows:

(1) Property pertinent to this claim is described as all interest in Heguy & Sons partnership.

The claim under the Itcaina Purchase is for two (2) priorities, 1907 from Pete Itcaina and 1885 from J.R. Bradley & Sons for a total of 2,500 sheep. As the number of animals and specific areas of use have lost their identity by sales, divisions

of property and land management agency decisions, it is not possible to allocate the numbers to each priority. Based upon the statements contained in the publication of Nevada's Northeast Frontier cited above, that the Bradley use was upon Marys River within the National Forest, all use upon that source is 1885. The balance of the priority is a medium of both the Itcaina and Bradley, being 1896.

The undersigned, being first duly sworn, deposes and says that he owns or controls the livestock presently watered by the Claimant, and that the facts relative to the proof of subsisting right by JOSEPH W. HEGUY are full and correct to the best of his knowledge and belief [If proof is not made by claimant, deponent should state on this line by virtue of what authority he represents the claimant.] _____.


