

The original proof filed on behalf of Daniel H. Russell did not state a year of priority but did claim use by 4500 head of cattle for each source. Bruneau River Ranch, LLC, as successor to Daniel H. Russell is submitting this amendment to document a priority year and a realistic number of livestock.

In establishing a priority of use of water for irrigation records maintained in Elko County, Nevada evidence diversion of water beginning in 1887. As the purpose of such irrigation was to provide winter feed for livestock, grazing by livestock upon the open range and use of water began shortly thereafter. A review of the Elko County Assessment Records for 1896 reveals that the following predecessors of the claimant were assessed for number of livestock shown.

P.R. Prunty	26 cattle
C.E. Pearson	81 cattle

By 1904, the predecessors were assessed for the following numbers of livestock.

P.R. Prunty	156 head
C.E. Pearson	129 head
P.A. Thourat	12 head
Isaac Griswold	<u>150 head</u>

Subsequent to the passage of various statutes concerning use of waters by livestock enacted by the State of Nevada livestock owners were encouraged by the State Engineer to file maps with that office showing the area used by them for open range grazing. Horace C. Shively, the successor to the above named filed such a map, as did his son Frank P. Shively who ran livestock with his father (See range maps 676-34 and 677-34 or file in the State Engineers office). The area of use shown on the maps includes various sources of livestock water claimed by Daniel H. Russell.

In addition, through public land administration by the Bureau of Land Management, establishment of grazing allotments and sales of ranches, Bruneau River Ranch, LLC acquired some public grazing lands originally used by Evans & Bros, during the period of the sale of the ranch property from North Fork Cattle Co. to Monfort Finance Company, Inc. between 1984 to 1995.

Elko County Assessor records show that by 1888 the Evans Bros., predecessors of North Fork Cattle Co. owned 1400cattle. A small portion of the area of use of North Fork Cattle co. is attached to the present Bruneau River Ranch, LLC operation being for an estimated 60 head of livestock.

Therefore a total of 507 head of cattle is claimed with a priority date of 1896. The period of use was April through November.

Chattel Mortgages of record in the Office of Elko County Recorder evidence that P.R. Prunty and Horace C. Shively, predecessors of Bruneau River Ranch, LLC, operated small bands of sheep in the area. As late as 1929, a chattel mortgage given by Shively and Prunty for 1,050 sheep at a ratio of five sheep being equal to 1 cow, this would equate to an additional 210 head of cattle in the area of use.

At the present time, grazing use authorized by the Bureau of Land Management in the area is 459 cattle, which compares favorable to the number of 507 head of cattle with no consideration for sheep use.

The total claimed number do not use this source during the entire grazing season, but are rotated through a pasture management program.

The point of diversion given in the proof is the lowest downstream point with the intent being that diversion is made from that point upstream. See Affidavit of Walter I. Leberski attached and Chain of Title which evidences predecessors of the claimant.

I, WALTER I. LEBERSKI, do hereby swear (or affirm) under penalty of perjury that the following assertions of this Affidavit are true.

1. I participated in the submission of proofs of appropriation of use of water for irrigation and stockwater upon the Owyhee and Bruneau Rivers.
2. During the course of completion of these proofs, I co-operated with Michael D. Buschelman, who submitted proofs as the agent for Daniel H. Russell and conferred with Michael Turnipseed, the State Engineer during that period of time.
3. On proofs of appropriation for watering livestock, Michael D. Buschelman did not specifically describe the beginning and the end of the reach of the channel used by livestock, but described only the location of the end of the reach with the intent that diversion by livestock would be from the described point upstream and include all tributaries within the area of use.

This Affidavit is made for the purpose of clarifying item 4 of Proof Numbers V07055, V07056, V07057 and V07058.
