(9) The approximate number of animals watered by the claimant during the first year 1879 was 580 cattle. The watering was conducted during each of the following months: Jun. 1 thru Nov. 30

(11) The amount of water which has been necessary to be diverted for this purpose has been 0.02 cubic feet per second.


