the order dated March 1, 1971, "In the matter of the determination of the
relative rights in and to the waters of Craine Creek, Knott Creek, Cove Creek,
Corral Creek and Center Creek and their tributaries in Humboldt County State
of Nevada," Sixth Judicial District Court No. 7295--Findings of Fact, Conclusions
of Law, Judgment and Decree. This spring is a major source of stock water that was
overlooked during the adjudication of Cove Creek. Applicant is the successor
in interest to Nevada Alder Creek Ranch and thus claims all of the rights
previously afforded to Nevada Alder Creek Ranch. The chain of title from

Remarks Nevada Alder Creek Ranch to R.D.D., Inc. is included with this filing.
Applicant believes that this spring was overlooked as a stock water source during the adjudication because the water source was on private land. During the summer months, this water source does not reach the Cove Creek drainage.
