

Addendum  
to Proof of Appropriation of Water  
for Stockwater Purposes  
by  
Cottonwood Ranch, LLC

The priority set forth in Section 9 is based upon the information contained in the affidavit of Walter I. Leberski, attached.

The chain of title attached to said affidavit evidences that W. T. O' Neil mortgaged 1000 head of cattle and 50 head of horses in 1885 to E. P. Hardesty. The chattel mortgage states the cattle were located in the Salmon River Range. The publication entitled "Nevada's Northeast Frontier" by Edna B. Patterson, et al, identifies the O' Neil - Capell Partnership Operation as being located at the head of the Little Salmon River (O' Neil Basin) which is the location of the claimant's operation. This publication further identifies William O' Neil, which the chain of title evidences, is a predecessor of the claimant. From this information, a priority date of 1885 is considered to be reasonable.

The mortgage to E. P. Hardesty evidences at least 1000 cattle and 50 head of horses watering from various sources within the O' Neil Basin by 1885. It is evidenced that the number of livestock grazing in the area increased by the purchase of sheep (1355 head in 1892) and by 1907, the Elko County assessor charged the O' Neil - Capell Livestock with 58 horses, 1135 cattle and 6,150 head of sheep. Further records indicate the sheep used the O' Neil Basin area only during a portion of the year.

Claimant grazes upon only a portion of the area which was historically used by the O' Neil operation. Range Maps were filed in the Office of the State Water Engineer in accordance with the 1927 Stock Water Act on behalf of Emery C. Smith, Nevada Smith and Esther Teresa Boies, who were successors to O' Neil's and predecessors to the claimant. These maps showed the grazing area of Emery C. Smith and Nevada Smith, who were predecessors, as being within T44 & 45N, R61 & 62E, T42NR61E and T46 & 47N, R61 & 62E, MDB&M. During the establishment of private allotments the area of use, was changed and the source of their claim is within the claimant's private allotment. The range maps identified above, excluded the area of use within the National Forest.

However, the claimant's predecessors historically grazed livestock upon Forest Service lands. In order to qualify for a Forest Grazing Permit, it is necessary that predecessors of the holder of such a permit grazed and claimed use upon the present Forest lands prior to the establishment or withdrawal of the Forest lands. As the claimant holds a Forest permit, it is evidenced that his predecessors made use of sources of livestock water now within the National Forest.

The number of animals making use of this source is based upon the claimant's experience in managing livestock and the production of water of this source. The number making use of the source is not continuous during the grazing season, but does represent the number which use the source during portions of the season.

The claimant uses a number of sources for livestock water and the use by each source is not additive to the total number of sources.

I, Walter I. Leberski, do hereby swear (or affirm) under penalty of perjury that the following assertions of this affidavit are true.


1. That I am an adult and a resident of the County of Elko, State of Nevada.
2. That I searched records of the Elko County Recorder and Elko County Assessor for the evidence of livestock numbers and place of use range grazing operations prior to 1905 in the area known as O' Neil Basin, at the headwaters of the Salmon Falls Creek in North Central Elko County.
3. The purpose of the research was to determine the number of livestock and years of early grazing use which were based upon private lands in Sections 31, 32 and 33, T45NR61E and grazing allotments upon public and Forest reserve lands now owned by Cottonwood Ranch, LLC.
4. The Chain of Title, consisting of 4 pages, summarizes the results of this search.
5. Said search reveals that W. T. O' Neil operated cattle in the Salmon River Range as early as 1885 as evidenced by a Chattel Mortgage executed by W. T. O' Neil to E. P. Hardesty recorded September 12, 1885 in Book 1 of Bill of Sale at page 29, Elko County, Nevada.
6. W. T. O' Neil, as evidenced by the above described Bill of Sale owned 1000 head of cattle and 50 horses in 1885.
7. The assessment roll of Elko County, Nevada for the year 1907 assesses O' Neil - Capell Livestock for 58 horses, 1135 cattle and 6,150 sheep.
8. The publication entitled "Nevada's Northeast Frontier" by Edna B. Patterson, Louise A. Ulph and Victor Goodwin identifies the O' Neil - Capell partnership being located at the head of Little Salmon River (O' Neil Basin) and William O' Neil being one of the partners.

9. That I obtained copies of maps filed with the Nevada State Water Engineer filed on behalf of Emery C. Smith, Nevada Smith and Esther Teresa Boies which were filed in accordance with the 1927 Stock Water Act and said map depicts the area of grazing use claimed in 1927. See map filed in the office of the State Water Engineer (179-30, 180-30 & 181-30).
