**Remarks** (Improvements, title, etc.)

The area of use of the source of water of this proof is within the Harrison Pass allotment of the Ruby Mountain Ranger District, Toiyabe-Humboldt National Forest. In order to hold a grazing permit within the Forest Reserve, it is necessary the permitter be a successor in interest to a party who grazed livestock within the area prior to the creation of the Forest Reserve in 1905. The claimant is a successor of Albert Hankins grazed livestock in the area of the source as shown on the Zunino Chain of Title attached. Affidavits of Walter I. Leberski, Paula Bergeron and James L. Gregory.

The priority claimed is 1882 based upon priorities for irrigation water as recognized in the Humboldt River Adjudication and tax assessment records of Elko County, Nevada. The Humboldt River Adjudication shows irrigation of the ranch property which was associated with grazing use within the area of the source began in 1871 with the development of the majority of the irrigated lands having various other years of priority up until 1881.

In 1882, the Elko County Tax Records assessed the Henry Bros. (Gilbert and Joseph Henry) for 60 horses, 20 cows and 250 stock cattle and for the property known as the Charles Adams Ranch and a ranch upon Smith Creek. By 1897, predecessors to the claimant were assessed for the following livestock numbers:

<u>Joseph Henry</u>	<u>125 horses &amp; 150 cattle</u>
<u>Thomas Moody</u>	<u>40 horses &amp; 40 cattle</u>
<u>Charles Adams</u>	<u>350 cattle</u>

By 1903, Hankins Bros. had consolidated the ownership of private property owned in Ruby Valley (T29N, R58E, MDM) and Mound Valley (T29N, R56E, MDM) for which they were assessed along with 950 head of cattle.

The vicinity of the ranch property to the present Forest lands the fact that the livestock were grazed upon the open range in the area of the source and the recognition of the Forest Service of such use by a later grazing permit evidences use upon the source prior to 1905. The priority year of 1882 is considered to be conservative. The number of livestock on the source coincides with the number of livestock permitted at the present time.

The allotment is in a grazing rotation management plan. Therefore the livestock do not use the source during the entire period of May 1 to November 1, but during the portion of the grazing season allowed under the plan.

The undersigned, being first duly sworn, deposes and says that the facts relative to the appropriation of water by Barnes Ranches, Inc. are full and correct to the best of his knowledge and belief



Charles Adams	350 cattle

By 1903, Hankins Bros. had consolidated the ownership of private property owned in Ruby Valley (T29N, R58E, MDM) and Mound Valley (T29N, R56E, MDM) for which they were assessed along with 950 head of cattle.

The vicinity of the ranch property to the present Forest lands the fact that the livestock were grazed upon the open range in the area of the source and the recognition of the Forest Service of such use by a later grazing permit evidences use upon the source prior to 1905. 
