The spring was first developed to serve ranchers and miners in the area associated with livestock grazing animals belonging to predecessors of the claimant. Rawhide Ranch owns 80 acres of deeded land to the northwest on the Dunlap Canyon Road and at Tule Spring (also called Southern Pacific Spring). The Pilot-Table Mountain Allotment (See Map) is a water based grazing allotment.


