Remarks

The Middle Summit spring was first developed and/or used in the late 1800's to serve ranchers and miners in the area associated with livestock grazing animals belonging to predecessors of the Claimant. Rawhide Ranch owns 80 acres deeded land to the northwest at Dunlap Canyon Road and Tule Spring (also called Southern Pacific Spring) and +100 acres to the west at Sodaville, Nevada. The Pilot-Table Mountain Grazing Allotment (See attached map) is a water based grazing allotment.

The undersigned, being first duly sworn, deposes and says that the facts relative to the appropriation of water by David G. Holmgren and/or Jackie A. Holmgren are full and correct to the best of his/her knowledge and belief.




