Remarks

The Wide Canyon Spring was first developed and/or used in the late 1880's to serve ranchers and miners in the area associated with livestock grazing animals belonging to predecessors of the Claimant. Rawhide Ranch owns deeded land in Dunlap Canyon and at Tule Spring (also called Pacific Spring), as well as at Sodaville. The Pilot-Table Mountain Grazing Allotment (See attached map) is a water based grazing allotment.






