of water per second has been used to irrigate 342.58 acres of land and 4.0  
acre-feet per acre per annum have been used to irrigate the crops.

(20) Remarks

The Deep Hole Ranch area was originally settled in 1852 as a stop on the Noble's Emigrant Trail between the Black Rock Desert and the Honey Lake Valley. Active agriculture of the lands irrigated on the Deep Hole Ranch was first noted in field notes of the 1873 U.S. General Land Office survey by Garside. Artesian wells were first noted in the U.S. General Land Office 1916 dependent resurvey of portions of T.33N., R.22E., M.D.B. & M. By 1890, the Deep Hole Ranch had become the headquarters of the Louis Gerlach's livestock operations. For further information please refer to the chronology and documentation attached to this Proof.

A total of 342.58 acres is irrigated from all water sources on the Deep Hole Ranch property including Proofs 09071 through 09082 and 09087 through 09089. The acreage and culture claimed is as depicted on the map prepared by F.B. Stewart of the Nevada State Engineer's office in 1915.

The undersigned, being first duly sworn, deposes and says that the facts relative to the appropriation of water by  
Deep Hole, LLC, a Nevada limited liability company are full and correct to the best of his knowledge and belief.

Deponent is an employee of TEC Civil Engineering Consultants and has been hired by the Claimant to prepare this proof
