Remarks

The entire Chain of Title is contained in File V 01933. Flow measurements were made on August 24, 2010. The total, measured flow from Butcher Canyon and Jersey Hot Springs equaled 0.139 CFS which contributes to aquifer recharge of Jersey Hot Springs ("F" and "C") in SE $\frac{1}{4}$  Section 29 T. 27 N., R. 40 E. and a pipeline which carries water to the Home Station Reservoir and its irrigated lands. Also the diversion ditch on Butcher Canyon is supported with spring recharge. Cedar Canyon total measured flow was 0.027 CFS, which flows directly into Home Station Reservoir. The measured flow of Home Station Wash was 0.011 CFS supports flow through recharge of the aquifer and is applied on fields at Home Station Ranch. Previously, other springs within the aforementioned drainages have had Proofs filed on Home Station Wash and Cedar Canyon.

The undersigned, being first duly sworn, deposes and says that the facts relative to the appropriation of water by Mike and Barbara Stremler are full and correct to the best of his/her knowledge and belief.

The claimants above have given Sam E. Monteleone the authority to act as their agent in filing this Proof.


