ADDITIONAL SUPPORTING REMARKS REGARDING THIS PROOF'S FILING

Water from this spring has been in continuous use since 1867 when the Miller and Lux ranching concern ran cattle in Humboldt County. The Chain of Title from Miller and Lux through B. F. Porter Estate to the current owners is in documented in the State Engineer's Office (Please see Decrees for Piute Creek, Battle Creek, and Bartlett Creek).

The basis for using the name "Running Water Spring" is from the designation on the U. S. G. S. 7½ Quadrangle map-Big Mountain. Other parties have used the name Parman Spring No. 2. At this time, there are no Permits or Proofs for this Spring.

Greg L. and Mary Anne Foster are the sole owners of the Paiute Meadows Grazing Association, LLC who are the owners of the Paiute Meadows grazing allotment administered by the U. S. Bureau of Land Management.


