Remarks: This proof of appropriation is being filed in response to State Engineer Notice of Order Initiation Proceeding to Determine Water Rights dated July 9, 2010, State Engineer Notice of Order for Taking Proofs dated August 25, 2010, and State Engineer letter extending time to file proofs dated December 20, 2010. Water was appropriated from Butcher Canyon Wash for stockwatering by the Clarks around 1873, the Abels around 1879, the Leicks around 1890, and the Savals around 1900. Joe Saval Company LLC ultimately acquired these water rights through its acquisition of Buffalo Ranch, Clark Ranch, and Jersey Ranch and their appurtenant water rights. Joe Saval Company LLC has also submitted a memorandum detailing its water rights in the adjudication area.




