THE FIRST DOCUMENTARY EVIDENCE OF HIS PRESENCE ON THE SUBJECT LANDS IS STATE SELECTION APPLICATION NO. 6275, FILED JULY 11, 1885 IN THE OFFICE OF THE REGISTRAR, NEVADA STATE LAND OFFICE.


