

## ATTACHMENT

This claim is made under NRS 533.492 and NRS 533.493 which allows for recognition of a right to water range livestock within a basin where rights have been adjudicated. As this claim is within the adjudicated Humboldt River Basin it is based upon a subsisting right with a priority prior to 1905. The claim does not represent an additional water demand, over that allowed in the Humboldt River Decree but identifies the source, location and numbers of livestock.


Total water consumption by livestock within the grazing area of the claimant is not additive from all sources and is limited by 2,500 head of cattle using all water sources within the grazing area of the claimant.

The major predecessor of the claimant as to owned range lands is Hunter-Banks Company and that company's median priority from the Humboldt River Decree is 1886. This year of priority substantially agrees with the Tabulation Sheet as reviewed in the affidavit of Walter I. Leberski attached to the claim and therefore the year of 1886 becomes the priority.

Attached is an allotment map depicting the area of use of the claimant upon the public land and the source of this claim is within that area.



# Lone Mountain Allotment

I, **WALTER I. LEBERSKI**, do hereby swear (or affirm) under penalty of perjury that the following assertions of this Affidavit are true.

1.       That I am an adult, and a resident of the County of Elko, State of Nevada.
2.       I have reviewed records available in the State Engineer's Office and Elko County Recorder's Office for historical grazing use in T35N, R54E; T36N, R54E; T37N ,R53E; T37N, R54E; T37N, R55E ; T38N, R54E; T39N, R54E; and T39N, R55E all MDM to determine the owners of livestock in those townships and year of priority of use in connection with a claim of a subsisting stock water right.
3.       The claimant provided to me a document entitled "Taylor Grazing Act Tabulation Sheet" for H. Moffatt Co. which does not indicate year it was prepared but does state a priority of 11 years.
4.       As a former employee of the Bureau of Land Management, I am familiar with this form as being a summary of priority statements made by H. Moffat Co. and Dependent Property surveys made by the Taylor Grazing Services, now Bureau of Land Management for grazing preferences upon the public lands
5.       The priority of 11 years shown on the form would be from June, 1929, the beginning of the priority period under the Taylor Grazing Act and the form would have been no later than for the year of 1940..
6.       The Tabulation notes that predecessors made grazing use 40 to 60 years prior or between 1900 and 1880.
7.       The tabulation also identifies the area of use to include those townships listed in

Paragraph 2 above.

8. Also attached are 2 pages of a Dependent Property Survey which I obtained from Bureau of Land Management files on the H. Moffat Co. Operation prepared by Francis A. Riordan dated December 1, 1938.

9. Page 1 of the above described report shows a normal operation consisting of 12,056 head of livestock and Page 4 outlines the Federal Range use and this document compares favorably with the Tabulation Sheet referred to in Paragraph 3 above as to numbers of livestock and area of use

10. Range Maps for H. Moffat Co., Jose Yraguen and Hunter Banks Co. as filed in the State Engineer's Office were also reviewed as those parties are predecessors to the claimant and those maps evidence that the customary area of use of those predecessors is part of the area of use of the claimant. Copies of those maps are attached.

11. The area of grazing use of the claimant is within the Humboldt River Basin and the adjudication decree for that basin contains the following language:

“That the right to the diversion and use of the water for stock and domestic purposes shall be continued by such claimants and such water users at any time during the year, and such diversion shall be according to the dates of priority of such claimants, and such use shall be limited to the quantity of water reasonably necessary for stock . . .”

12. It is understood that the above statement in the Humboldt River Decree applies to stock water within the area of culture set forth in the Decree and the area of use of the claimants in the Decree upon open, public land grazing and based upon that the priorities of use for predecessors as set forth in the Decree were found to be as follows:

Griswold Henderson Livestock Company	1869 to 1902
Rufus Kimball	1870 to 1900
Hunter-Banks Company	1876 to 1898
W.T. Jenkins Company	1885 to 1896
T.S. Park	1865 to 1901



13. The Tabulation Sheet described in Paragraph 3 refers to 13,500 head of cattle being customarily ran which compares favorably to the Dependent Property Survey referred to in Paragraph 8 making the number of 2500 head of cattle in the area described in Paragraph 2 being reasonable.

This affidavit is made for the purpose of providing evidence of an area of use and priority of use for Dorsey Land, LLC for a claim of a Subsisting Right of Water for Stock Watering purposes.


