Warren W. Williams was located in Edwards Creek Valley prior to 1878. His house/ranch was located on the E 1/2 of SE, Section 5, T19N R37E, MDBM, and named on the General Land Office Survey Map, approved 11/28/1879. Assessor's records of 1883 state W.W. Williams had 4,000 head of sheep.

The undersigned, being first duly sworn, deposes and says that the facts relative to the appropriation of water by Michael A. Casey are full and correct to the best of his/her knowledge and belief.

If proof is not made by claimant, deponent should state on this line by virtue of what authority he/she represents the claimant.


