The lands upon which Swingle Spring is located were first used for livestock watering by the Gerlach Livestock Company in 1890. Later, Gerlach and Waltz grazed cattle and sheep in this area. This spring is also listed as a source of water under Permit 6878, Certificate 1151, issued for irrigation and domestic purposes which is also owned by the Claimants.

The undersigned, being first duly sworn, deposes and says that the facts relative to the appropriation of water by Robert R. Depaoli and Debra M. Depaoli are full and correct to the best of his/her knowledge and belief. Deponent is an employee of TEC Civil Engineering Consultants and has been hired by the Claimant to prepare this Proof.

If proof is not made by claimant, deponent should state on this line by virtue of what authority he/she represents the claimant.


