Remarks [Improvements, title, etc]

This claims for numbers of livestock and priority of use is based primarily on the affidavit of Walter I. Leberski. This affidavit points out the complex history of the area of use and waters of the claimant due to the number of past livestock operators in the area and numerous purchases of portions of those historical operations. This affidavit shows early use of the source by E.P. Hardesty for a reported number of 2,000 cattle in 1872 to 800 in 1890. Many of the subsequent operators were successors of Hardesty and may have augmented the high numbers of livestock reported in 1872 prior to 1905. The successor operators were Badt, Weeks, Conway, Steele, Agee, Truett and Anderson and they were assessed in excess of 2,900 head of cattle by 1903. In addition, the claimant acquired a portion of L.L. Bradley operation and the area of use claimed by John and Robert Marble as shown on their filed range claim map. Bradley was assessed for 1,750 cattle. In addition the claimant acquired all of the property of the Estate of Samuel McMullen and Isaac Griswold for a total of 620 cattle and their area of use as recognized by the Bureau of Land Management as being within the allotment of the claimant.

Priorities indicated range from 1972 to possibly 1903 for the higher numbers shown in the affidavit. However, as the major portion of the use is based on McMullen, Bradley, Griswold and Hardesty, a conservative priority or 1890 is

claimed.

The exhibits attached to the affidavit, repeatedly state large numbers of livestock being grazed in the area of the claimants present allotment. With the passage of the Taylor Grazing Act and subsequent management of the area by the Bureau of Land Management, these numbers have been greatly reduced and the number of livestock set forth in the claim are near the number presently permitted within the allotment area of the claimant. For that reason, the number of livestock claimed is considered to be greatly reduced from the number of livestock which grazed the area prior to 1905 and are conservative.

This claim is one source of stockwater of several within the grazing area of the claimant. The consumption of water by livestock within that area is not additive from all sources and the total combined duty of water from all sources does not exceed that amount sufficient to water 2,700 head of cattle.

The undersigned, being first duly sworn, deposes and says that the facts relative to the appropriation of water by **The William Max Spratling Living Trust dated February 9, 2001** are full and correct to the best of his knowledge and belief. **The original Trustee of the William Max Spratling Living Trust was William Max Spratling, now deceased, and pursuant to the terms of the trust, William Craig Spratling is the successor Trustee.**
