Flanigan had a ranch house located in SE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 17, T. 26 N., R. 20 E., M. D. B. & M. Another rancher, J. Clifton, had a place near Round Corral and Lower Round Corral Springs in the NE $\frac{1}{4}$ Section 21, T. 25 N., R. 20 E., M. D. B. & M. Between these three ranches, stock water from all of the Springs and Seeps in the area provided water for cattle, commencing in 1884 and continuing to the present day. The Quarter-Quarter subdivisions used on this Proof were obtained from the BLM's Geocommunicator Website. There was a "location" discrepancy with U. S. G. S. 7.5 minute topographic maps.

The undersigned, being first duly sworn, deposes and says that the facts relative to the appropriation of water by ZZ-30, LLC are full and correct to the best of his/her knowledge and belief. This Proof is being made by Sam E. Monteleone, as authorized agent for the Claimant.
