County, State of Nevada, for the following reasons and on the following grounds, to wit:  
THIS APPLICATION IS ONE OF 146 APPLICATIONS FILED BY THE LAS VEGAS VALLEY WATER DISTRICT SEEKING A COMBINED APPROPRIATION OF SOME 864,195 ACRE FEET OF GROUND AND SURFACE WATER PRIMARILY FOR MUNICIPAL USE IN CLARK COUNTY. UPON INFORMATION AND BELIEF, DIVERSION AND EXPORT OF SUCH A QUANTITY OF WATER WILL DEPRIVE THE AREA OF ORIGIN OF THE WATER NEEDED TO PROTECT AND ENHANCE ITS ENVIRONMENT AND ECONOMIC WELL BEING. INASMUCH AS A WATER EXTRACTION AND TRANSBASIN CONVEYANCE PROJECT OF THIS MAGNITUDE HAS NEVER BEEN CONSIDERED BY THE STATE ENGINEER, IT IS IMPOSSIBLE TO ANTICIPATE ALL POTENTIAL ADVERSE AFFECTS WITHOUT FURTHER INFORMATION AND STUDY. ACCORDINGLY, THE PROTESTANT RESERVES THE RIGHT TO AMEND THE SUBJECT PROTEST TO INCLUDE SUCH ISSUES AS THEY MAY DEVELOP AS A RESULT OF FURTHER INFORMATION. THE UNDERSIGNED ADDITIONALLY INCORPORATES BY REFERENCE AS THOUGH FULLY SET FORTH HEREIN AND ADOPTS AS ITS OWN, EACH AND EVERY OTHER PROTEST TO THE SUBJECT APPLICATION FILED PURSUANT TO NRS 533.365.

THEREFORE the protestant requests that the application be DENIED  
(Denied, issued subject to prior rights, etc., as the case may be)

and that an order be entered for such relief as the State Engineer deems just and proper.
