ATTACHMENT TO PROTEST OF APPLICATION NO. 54024 FILED OCTOBER 17, 1989

BY LAS VEGAS VALLEY WATER DISTRICT

The granting or approval of the above-referenced Application would conflict with or tend to impair existing rights as well as the ability to fully develop the existing privately owned productive lands in the Snake Valley. Diversion and export of such a quantity of water will: lower the static water level, adversely affect the quality of remaining ground water and further threaten springs, seeps and phreato-phytes which provide water and habitat critical to the survival of grazing our livestock, wildlife, and other surface area uses, in addition to underground water sources for these purposes, including domestic livestock watering, irrigation and wells.

The undersigned additionally incorporates by reference as though fully set forth herein and adopts as its own, each and every other protest to the subject application filed pursuant to NRS 533.365.

Inasmuch as a water extraction and transbasin conveyance project of this magnitude has never been considered by the State Engineer, it is therefore impossible to anticipate all potential adverse effects without further information and study. Accordingly, the protestant reserves the right to amend the subject protest to include such issues they may develop as a result of further information and study.
