ATTACHMENT TO PROTEST OF APPLICATION NO. 54027  
BY LAS VEGAS VALLEY WATER DISTRICT

Application No. 54027, if approved, would prevent or interfere with the development of the community water supply in Snake Valley. The Baker Water & Sewer General Improvement District was formed for this purpose after completion of an engineering study by Eric Beyer. This study designated a source for the Baker water system that is located adjacent to Application No. 54027. Said water system is critically needed for the health and economic well-being of Snake Valley, as well as for serving the needs of some 80,000 annual visitors to Great Basin National Park.

Approval of this application would jeopardize the community water supply that is now being developed in Snake Valley for the town of Baker, by means of the Baker General Improvement District. This quasi-municipal water system is necessary for the healthy growth and economic development of Snake Valley, and to serve the 80,000 annual visitors to Great Basin National Park.
