WATER FOR MUNICIPAL USE IN THE LAS VEGAS VALLEY ARTESIAN BASIN. DIVERSION AND EXPORT
OF SUCH A QUANTITY OF WATER WILL DEPRIVE THE COUNTY AND AREA OF ORIGIN OF THE
WATER NEEDED FOR ITS ENVIRONMENT AND ECONOMIC WELL BEING AND WILL UNNECESSARILY
DESTROY ENVIRONMENTAL, ECOLOGICAL, SCENIC AND RECREATIONAL VALUES THAT THE STATE
HOLDS IN TRUST FOR ALL ITS CITIZENS. (BASIN 202)


