

Appropriation and use of this magnitude will lower the water table and degrade the quality of water from existing wells, cause negative hydraulic gradient influences, further cause other negative impacts and will adversely affect existing rights adverse to the public interest.

and that an order be entered for such relief as the State Engineer deems just and proper.


Dear Sir;
