THIS APPLICATION IS ONE OF 144 APPLICATIONS FILED BY THE LAS VEGAS VALLEY WATER DISTRICT SEEKING A COMBINED APPROPRIATION OF SOME 860,000 ACRE FEET OF GROUND AND SERVICE WATER FOR MUNICIPAL USE IN THE LAS VEGAS VALLEY ARTESIAN BASIN. DIVERSION AND EXPORT OF SUCH A QUANTITY OF WATER WILL DEPRIVE THE COUNTY AND AREA OF ORIGIN OF THE WATER NEEDED FOR ITS ENVIRONMENT AND ECONOMIC WELL BEING AND WILL UNNECESSARILY DESTROY ENVIRONMENTAL, ECOLOGICAL, SCENIC AND RECREATIONAL VALUES THAT THE STATE HOLDS-IN-TRUST FOR ALL ITS CITIZENS.

THEREFORE the protestant requests that the application be Denied

and that an order be entered for such relief as the State Engineer deems just and proper.


