County, State of Nevada, for the following reasons and on the following grounds, to wit:

The granting and approving of this application would be of a severe detriment in several areas: 1. In the absence of proper planning, including but not limited to environmental impact considerations, socioeconomic impact considerations, and water resource planning, such as required for private purveyors of water, the application is detrimental to the public welfare and interest, and pleads for special consideration above what is considered normal for public applications; 2. Diversion and export of such a quantity of water will adversely affect the quality of remaining ground and underground water and will further threaten springs, wells, seeds & phreatophytes which provide water and habitat critical to the survival of wildlife, grazing livestock, and endangered species; 3. This diversion will unnecessarily destroy environmental, ecological, scenic and recreational values that the State holds in trust for all its citizens; 4. This application, when combined with others in the same local, will cause an undo and unnecessary strain upon those creatures, both human and otherwise, who depend upon water for survival; and 5. The approval of subject application will sanction, enhance, and grant approval of the willful, negligent, and perhaps encouraged waste of water allowed and unpunished by the Las Vegas Valley Water Dist.

THEREFORE the protestant requests that the application be Denied

(Denied, issued subject to prior rights, etc., as the case may be)

and that an order be entered for such relief as the State Engineer deems just and proper.


