County, State of Nevada, for the following reasons and on the following grounds, to wit:

- 1) The amount of water requested by this application does not exist reliably for the Maynard Spring complex. See Attachment A.
2) Over appropriation of the source would prove detrimental to the public interest.

SNWA requests that this application be denied. In the alternative, SNWA requests that if the application is approved, in order to prove beneficial use, USFWS should be required to install a gaging station and to submit continuous mean daily values to the State Engineer to support the permitted flow rate. If actual measured flows do not match permitted flows consistently, any certificate issued should only reflect actual flows. SNWA also requests that the permit terms include an annual reporting requirement.

THEREFORE the Protestant requests that the application be

denied

Denied, issued subject to prior rights, etc., as the case may be

and that an order be entered for such relief as the State Engineer deems just and proper.
