

## ATTACHMENT.

THE DUCK LAKE VALLEY APPLICATIONS FOR UNDERGROUND WATER, GIVE US CONCERNS IN THE SURPRISE VALLEY REGION, WE ARE LOCATED IMMEDIATELY TO THE NORTH OF DUCK LAKE VALLEY, AND WE HAVE THE FOLLOWING REASONS FOR OUR CONCERNS:

1. A GEOLOGICAL FAULT ZONE IS EVIDENT ON THE SOUTH END OF SURPRISE VALLEY BY AN INSPECTION OF THE TOPOGRAPHICAL FEATURES, APPROXIMATELY  $2\frac{1}{2}$  MILES SOUTH EAST OF THE BARE RANCH.

2. THIS FAULT ZONE CONNECTS A LOWER DRAINAGE AREA (DUCK LAKE) TO A HIGHER UNDERGROUND SOURCE (SURPRISE VALLEY).

3. SIGNIFICANT PUMPING FROM THE DUCK LAKE AQUIFER WILL LOWER THAT GRADIENT AND ALLOW TRANSFER FROM THE SURPRISE VALLEY RESOURCE.

THEREFORE, BEFORE ANY PERMITS FOR WATER EXTRACTION BE GRANTED IN THE DUCK LAKE VALLEY AREA, STUDIES MUST BE MADE TO DETERMINE THE ULTIMATE SOURCE OF THAT WATER.
